REPORT:

AWARENESS PROGRAMME ON LAWS RELATED TO WOMEN

Awareness programme on laws related to women in India is organized by Women Cell and Gender Equity Cell on 21st August 2025 in online mode. Resource Person of the programme was Dr. Asmita Patil, Associate Professor, Shahaji Law College, Kolhapur. She elaborated various legal provisions made in Indian Constitution and in other acts passed by the Government of India. She explained about the constitutional provisions of equality before law, right to live with dignity, right against exploitation, equal pay for equal work etc. She touched the various angles framed for the protection of women under Hindu Marriage Act, Special Marriage Act, Prevention of Sexual Harassment Act, Maternal Benefit Act, Pre-natal Diagnostic Act, National Commission for Women, Provisions made in Indian Penal Code, which has been converted into Bharatiya Nyaya Sanhita, Prohibition of Dowry Act, Criminal Procedure Code etc. She also given insights on how to utilize these acts and provisions for the betterment of women. But also raised concern about the misuse of some of the act to harass the husband and in-laws. This session is chaired by the Principal of our college Dr. Uttam Patil Sir and organized by the convener of this committee Prof. Dr. Akshata Gawade. Many Students and faculty members were attended the meeting. Overall this programme created awareness among the students and faculty members about the provisions available for women in India.
